Set performance milestones

Our team assessed system requirements in terms of features, performance, extensibility, scalability, and maintainability. We designed a customized sustainability reporting application in the absence of a suitable commercial off-the-shelf product. Our application supports incident, waste, and greenhouse gas data management. In addition, it provides visibility into community programs undertaken by the company.

Infosys developed the application using a diverse technology stack comprising Microsoft .NET, SQL Server, SQL Server Reporting Services (SSRS), SQL Server Integration Services (SSIS), and Component-based Scalable Logical Architecture (CSLA) framework. We created multiple interfaces to integrate the sustainability reporting system with application databases for one-click reporting.

Before rolling out the application, we mapped people, processes, and technology with sustainability goals of the oil and gas company. The application simplifies monthly and annual reporting of performance against milestones. It offers flexibility to choose reporting elements and generate ad hoc reports with graphical representation. Significantly, scalability of the system supports future enhancements.
