

Infosys Technologies to Announce Fourth Quarter and Annual Results on April 14, 2005

Bangalore, India and Fremont, California. – April 4, 2005: Infosys Technologies Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its Fourth Quarter and Year ended March 31, 2005 on Thursday, April 14, 2005, Indian Standard Time (IST) (on the night of Wednesday, April 13, 2005, US Eastern Time (ET)).
