

# Infosys to Announce Second Quarter Results on October 12, 2011

Bangalore, India and Fremont, California – September 29, 2011: Infosys Limited (NASDAQ: INFY), a world leader in consulting and information technology services, will announce results for its second quarter ending September 30, 2011 on Wednesday, October 12, 2011, Indian Standard Time (IST) (on the night of Tuesday, October 11, 2011, US Eastern Time (ET)).
